
21 for the reason that on or about December 22, 2011, to January 1, 2012, in Yellowstone

24 That from about December 22, 2011, to January 1, 2012, the Youth, KADE
25 EDWARD GIES, knowingly or purposely injured, damaged, or destroyed property of
another or public property without consent, and did so in a series of acts motivated by a

1 purpose or plan which resulted in the repeated commission of the same offense or that
2 affected the same person or persons or their property, to wit: the Youth with L.P. (born in
3 October 1995), T.B. (born in April 1997), J.E. (born in July 1996), and/or B.W. (born in
4 November 1995), damaged several vehicles, and the aggregated pecuniary loss is in
5 excess of \$1500.00; in Billings, Yellowstone County, Montana; all of which is a violation
6 of Sections 45-6-101 and 45-2-101(8), Montana Code Annotated, and against the peace
7 and dignity of the State of Montana.

1 L.P. denied any involvement with shooting out of windows or starting fire to any
2 vehicles.

3 Also on January 4, 2012, Billings West High School Resource Officer Jerry Smidt
4 learned that Witness2, a student, may have been involved in an arson incident on January
5 1. On January 5, 2012, Officer Smidt read Witness2 her rights with her legal guarding
6 present and Witness2 agreed to waive her rights and give a statement. Witness2 stated
7 she was with Witness3, also a student. Sometime after midnight the two of them went to
8 Lillis Park and contacted J.E., who came with T.B. and L.P. in L.P.'s silver four door car.
9 The five of them went to J.E.'s residence to pick up a BB gun. While driving around in
10 the west end area near Cook and Howard Witness2 heard the BB gun fire. They then
11 went to Gorham Park and shot off some fireworks. While in the area they stopped and
12 T.B. put a firework on a car hood. They then came to a vehicle believed to be a truck
13 with topper. J.E. shot out the window of the vehicle. T.B. lit up a firework and placed it
14 in the vehicle. As they drove off it looked like it was starting fire. Witness2 recalled J.E.
15 shooting out a window of an unknown company truck and at least one other vehicle. She
16 stated that she heard the gun go off a lot and she observed T.B. shoot at least once. T.B.
17 asked if the others in the car knew where to find Victim209's house. The five of them
18 went in L.P.'s car over to Cook and Howard and were able to locate Victim209's
19 residence. Witness2 stated the boys didn't like Victim209 but she did not know why.
20 They drove up and J.E. shot out some of the windows of Victim209's vehicle. T.B. got
21 out of L.P.'s vehicle, lit a firework, and threw it in the back seat of Victim209's vehicle.
22 As L.P. drove away from Victim209's residence, Witness2 could see flames in the
23 Victim209's vehicle. They then headed back towards the first vehicle that started fire. As
24 they got closer to the area they saw police, ambulance, and fire vehicles so the five of
25 them left the area in L.P.'s car. The girls were dropped off. Witness2 stated that she
never shot the BB gun and never threw a fire work at anything. She also stated that
Witness3 did not shoot the gun or throw fireworks.

17 On January 6, 2012, Officer Smidt read Witness3 her rights with her mother
18 present and Witness3 waived her rights and agreed to give a statement. She stated J.E.,
19 T.B., and L.P. met up with Witness2 and her at Lillis Park. They got into the car and
20 started driving around. They were in L.P.'s car and L.P. was driving. L.P. drove them
21 around on the west end by Miles School and the boys were lighting off fireworks and
22 throwing them. They stopped at Gorham Park. While at the park they lit off more
23 fireworks on the ground and drove off. As they drove around the west end J.E. began to
24 shoot out windows with a BB gun. Witness3 believed that they were car windows. At
25 one point L.P. stopped the vehicle. J.E. got out and placed a firework on the roof of a
silver 4-door car and lit it. They drove off and while driving around shooting out
windows, L.P. and J.E. tried throwing fireworks into other vehicles. They pulled up to
another vehicle and J.E. shot out the driver side window, J.E. then threw a firework in the
car and they drove away. J.E. and L.P. began talking about Victim209's vehicle. While
driving around the west end the car stopped. She believed this was Victim209's
residence. J.E. shot out the windows in Victim209's vehicle. T.B. got out placed a
fountain firework in Victim209's vehicle. They headed to J.E.'s house to drop off the
gun. She described the gun as a black pistol. After dropping off the gun they saw fire

1 trucks so she went home. She stated they started about 12:00 (midnight) and ended about
2 3:00 am. During this time she said that she was scared and that she and Witness2 never
3 shot the gun. She had no idea how many vehicles were damaged.

4 On January 6, 2012, Officer Smidt read J.E. his rights with his mother present and
5 J.E. agreed to waive his rights and give a statement. J.E. stated that he was with L.P. and
6 T.B. on December 27, 2011 from about 2:00 am to 4:00 am. They were driving around in
7 L.P.'s vehicle. They had J.E.'s BB gun, a CO2 powered pistol. They started by Gorham
8 Park and shot out windows of vehicles with his BB gun. They shot out at least 20
9 windows. He thought he personally shot out about 5 or 6. T.B. shot out a lot of windows.
10 On December 29, 2011, the three of them were again shooting out windows from
11 approximately 12:00 (midnight) to 2:00 am. This took place mostly on the west end of
12 Billings in the area west of Sunset Bowl and North of Monad to Broadwater.

13 J.E. stated that on December 31, 2011, after he got off work, he was with
14 Witness4. L.P. picked up him and T.B. Witness4 went home after approx. half hour.
15 J.E., L.P. and T.B. drove around and shot about 10 to 15 windows out of random
16 vehicles. They met up with Witness2 and Witness 3. While driving around they shot out
17 at least 2 more random vehicle windows. Witness2 brought fireworks with her. They
18 were driving around the area by Gorham Park. They stopped at a vehicle and T.B. placed
19 a fountain firework on the roof of the vehicle. They continued to drive around and J.E.
20 shot out the windows of another vehicle. They stopped again and T.B. threw a lit
21 fountain firework inside the vehicle. As they drove around they talked about Victim209.
22 J.E. did not like Victim209 because of a comment Victim209 said about a year ago. J.E.
23 had an idea where Victim209 lived and what vehicle Victim209 drove. They went to this
24 area and located Victim209's vehicle. J.E. said he shot out the windows and T.B. lit a
25 fountain firework and tossed it into Victim209's vehicle. T.B. then shot a full clip of
BBs into the front window of the residence. After that they panicked and L.P. dropped
everybody off. J.E. stated that he possessed two BB gun pistols but he only used one of
the BB gun pistols during this series of vandalism. J.E. went on to say T.B. possessed the
other BB gun they used in that series of vandalism. J.E. estimated that he shot about 50
cars during the early morning hours of January 1st. J.E. stated on December 27th they
shot 30 to 35 vehicles, on December 29th the shot 20 to 25 vehicles, and on December
31st the shot 50 to 60 vehicles. J.E. stated that neither Witness2 nor Witness3 shot the BB
pistols. J.E. admitted to having the BB gun at his home along with another one. J.E.'s
parents gave consent to search their residence and recover the gun. Officers recovered
two BB guns from J.E.'s bedroom, which were hidden between his box spring and
mattress.

23 On January 6, 2012, School Resource Officer George Zorzakis was contacted by
24 L.P. Officer Zorzakis was familiar with L.P. as he was a former student at Lewis and
25 Clark Middle School. L.P. stated he wanted to "turn himself in" for being "the driver in
the vandalisms." L.P. admitted that he had previously met with Officer Simpson and lied
to him during that interview. Officer Zorzakis contacted detectives. L.P. met with
Detectives Buxbaum and Richardson, Officer Zorzakis and his grandfather at the police
station. L.P. was read his rights and agreed to waive those rights by giving a second

1 statement to officers. L.P. requested his grandfather be present and the officers allowed
L.P.'s grandfather to be present for the statement.

2 L.P. admitted to the detectives that he had been driving his vehicle around the
3 west end of Billings and that he and his friends, J.E., T.B., KADE EDWARD GIES, the
4 Youth identified as "K.G." herein, and B.W. (born in November 1995) were all shooting
5 out windows and also using baseball bats on car windows and mirrors and that it started
6 after Christmas and continued for four nights. L.P. also stated that on New Year's Eve he
7 met up with his friends J.E. and T.B. After midnight they went over and picked up two
8 girls, Witness2 and Witness3. He stated that Witness2 had some fireworks. L.P. stated he
9 was driving his grandmother's vehicle and went on top of the rims for a while. They were
10 talking about the fireworks and L.P. stated that J.E. said lets go put a firework in
11 Victim209's vehicle as J.E. did not like Victim209.

12 L.P. stated they drove over to Victim209's house. J.E. shot out the window and
13 T.B. put a fountain firework into the vehicle which started a fire. They then started
14 shooting out more windows, J.E. shot out a couple of windows and L.P. shot out four or
15 five as it was hard for him to shoot while he was driving. They heard sirens as they were
16 near Victim209's neighborhood, so they went back over and saw that Victim209's car
17 was fully ablaze and the fire was going crazy. L.P. denied that they shot out Victim209's
18 house window. L.P. stated that they had three guns and that J.E., T.B., and he were
19 shooting and that they shot thirty to forty windows. L.P. also admitted that J.E. put some
20 fireworks on top of a car near Miles Avenue School and they watched it go off. They
21 then went over to a white Jeep or something similar on Cook Avenue. J.E. shot out the
22 window which didn't break all the way, so J.E. lit the firework and chucked it inside. L.P.
23 stated that these two vehicles were burned before they went to Victim209's house and
24 started his vehicle on fire. L.P. stated that Victim209 was the only victim they singled
25 out.

On January 9, 2012, Officer Smidt conducted a second interview with J.E. after
learning from detectives that bats appeared to have been used in some of the incidents.
J.E. was again read his rights with a parent present and again waived those rights. J.E.
provided a significant amount of additional information and incidents that were not
disclosed in his initial statement. J.E. stated that they started the vandalism on December
22nd using bats. J.E. stated that L.P., K.G. (born in October 1996) or B.W. (born in
November 1995) went with J.E. L.P. was driving his car and J.E. sat in passenger seat.
B.W. or K.G. sat in the back seat. They began around 12:30 am and ended around 3:00
am. During this time they drove around the west end. They would stop and use the bats to
damage vehicles. They had 2 bats. J.E. owned and L.P. owned the other. J.E. reported
that the bats were in the trunk of L.P.'s vehicle. J.E. felt that they damaged at least 50
vehicles that first night.

J.E. stated to Officer Smidt that on December 23rd he, L.P., B.W., and K.G. went
out again with the bats. They drove around the west end by Gorham Park & Big Sky
School. J.E. stated they damaged 45 to 50 vehicles. J.E. stated that on December 26th,
he, L.P., B.W. and K.G. again went out with the bats. J.E. believes they only damaged

1 five or six vehicles with the bats but that was the first night they started using the BB
2 gun. J.E. stated that on December 27th, he, L.P., K.G. and T.B. went out. J.E. recalled
3 using the BB gun that night but did not recall them using the bat. J.E. stated that on
4 December 28th, he went with L.P., K.G., and T.B. J.E. again recalled using the BB gun
5 but did not recall using the bat. J.E. stated that on December 29th, he went with L.P. and
6 T.B. He stated they shot out windows on the west end. He stated they also hit three
7 streets behind Walmart in the heights area. J.E. stated the on December 29th he went with
8 L.P. and T.B. He stated they shot out windows on the west end. J.E. stated on these
9 dates they went out from about 12:00 am to 4:00 am. J.E. believes they shot out windows
10 from 150 to 200 vehicles with the BB gun, damaged 50 to 100 vehicles with the bat, and
11 at least three house windows.

12
13 On January 10, 2012, Officer Smidt read K.G. his rights with his mother present.
14 K.G. agreed to waive those rights and provide a statement. K.G. stated he was only out
15 with the others on December 26th and 27th. K.G. recalled being with L.P., J.E. and T.B.
16 K.G. said that on December 26th he was in the west end area by Gorham Park. K.G.
17 stated he hit two windows with the gun. K.G. thought he hit four or five vehicles with
18 the bat. K.G. further admitted that J.E. and T.B. hit windows with the BB gun around 16
19 or 17 times. K.G. recalled that on December 27th he hit five windows with the BB gun
20 and three with the bat. On one of the nights Witness4 was with them for about an hour.

21
22 On January 10, 2012, Officer Smidt read Witness4 his rights with his mother
23 present. Witness4 agreed to waive those rights and give a statement to Officer Smidt.
24 Witness4 stated he was with J.E., L.P., and K.G. on or about December 30th. Witness4
25 stated they drove around in Witness4's vehicle and J.E., L.P., and K.G. talked about
using the BB guns and shooting out windows. Witness4 says he told them "no" and they
went to L.P.'s vehicle. He said then all got into L.P.'s vehicle and ended up south of
Zimmerman trial on a side street. Witness4 said J.E. shot out a window. Witness4 says
he then came up with an excuse and was dropped off. Witness4 thought he spent about
an hour to an hour and a half with the others. Witness4 denied shooting out any
windows.

19 On January 10, 2012, Officer Smidt read B.W. his rights with his father present.
20 B.W. agreed to waive his rights and provided a statement to Officer Smidt. B.W. stated
21 that on December 22nd, he was with L.P., K.G., and J.E. as they drove around the west
22 end of Billings. B.W. stated they used bats to damage vehicles. B.W. thought they
23 damaged about 22 vehicles that night. B.W. admitted he damaged a vehicle. B.W. stated
24 on December 29th he was hanging out with J.E., L.P., and K.G. Witness4 showed up
25 later. B.W. thought that Witness4 was present for some of the damage but that Witness4
never shot the gun. B.W. admitted to shooting the gun about three times. B.W. said they
played a game where you got to keep the gun as long as you did not miss a window.
B.W. thought they shot about 100 vehicles.

On January 10, 2012, Detectives Buxbaum and Richardson went to Bozeman,
Montana, to interview T.B. The detectives met T.B. and his mother at the juvenile
probation office. T.B. was read his rights with his mother present and agreed to waive

1 those rights by giving a statement to the detectives. T.B. stated that he and his mother
2 were in Billings during the Christmas break and into the New Year. They were staying on
3 the west end of Billings. T.B. admitted to going out with L.P., J.E., Witness2 and
4 Witness3 on New Year's Eve. While out they drove around in L.P.'s car and shot out
5 numerous car windows. T.B. talked about J.E. placing fireworks on top of a car and
6 lighting it. J.E. then shot out a window of a vehicle and placed a fountain type firework
7 inside causing a fire. They then went to Victim209's house looking for his vehicle. J.E.
8 shot out several windows and T.B. lit a fountain firework and placed it into the vehicle
9 starting a fire. T.B. stated that they drove back later and the vehicle was burning. T.B.
10 stated the two girls did not shoot out any windows, just J.E., L.P. and himself.

11 T.B. went on to state that he also went out on the Wednesday and Friday before
12 New Years and shot out windows with L.P., J.E., K.G., and Witness5 T.B. also stated to
13 the detectives that, at times, they used a bat to break windows, mirrors or cause damage
14 to vehicles. T.B. stated K.G. liked to use the bat. T.B. stated he used his BB/pellet gun
15 and that J.E. and L.P. also had BB/pellet guns. T.B. stated that they played a game. If the
16 person holding the gun shot a window then that person got to keep the gun and keep
17 shooting. When the person missed the gun went to someone else. T.B. stated that he and
18 J.E. were good shots. T.B. denied shooting at any moving vehicle but stated he talked
19 with J.E. about it. T.B. stated that his BB gun was at his house and wanted to know if the
20 detectives wanted it. T.B. made this after the detectives concluded his statement. The
21 detectives followed T.B.'s mother to her apartment building. After about 30 minutes of
22 looking they were unable to locate the BB gun.

23 On January 11, 2012, Officer Smidt conducted a third interview of J.E. Again
24 with his parent present he was read his rights, waived his rights, and agreed to give
25 Officer Smidt a statement. J.E. admitted that they did play a game that the holder of the
BB gun got to keep it as long as he did not miss the window. Officer Smidt went over a
calendar with J.E. to identify the people involved for each date:

December 22nd: J.E., L.P., B.W. and possibly K.G. (bat)
December 23rd: J.E., L.P., Witness5, and possibly T.B. (bat)
December 26th: J.E., L.P., K.G., and T.B. (BB gun and bat)
December 27th: J.E., L.P., K.G. and T.B. (BB gun and bat)
December 28th: J.E., L.P., and T.B. (BB gun and bat)
December 29th: J.E., L.P., B.W., and K.G. (BB gun)
December 30th: J.E., L.P., Witness4, and possibly T.B. and/or K.G. (BB gun)
December 31st: J.E., L.P., T.B. Witness2, and Witness3 (BB gun and fireworks)

23 On January 11, 2012, Officer Smidt read Witness5 his rights with his father
24 present. Witness5 agreed to waive his rights and provide a statement to Officers Smidt.
25 Witness5 stated that after Christmas, L.P., J.E., T.B, and K.G. came by his home and
talked about bats and they all went out driving. The vehicle stopped and L.P. or J.E. took
a silver bat and smashed an older 4-door reddish Caviler car. They drove around some
more and he fell asleep. Witness5 stated they did not use the BB gun that night.


