

RESOLUTION NO. 10-68

**RESOLUTION EXPANDING RURAL SPECIAL
IMPROVEMENT MAINTENANCE DISTRICT #650M
(INDIAN CLIFFS SUBDIVISION-ROADS)**

WHEREAS, the Board of County Commissioners have determined that properties listed below are benefited properties and should be included in an expansion of the rural special improvement maintenance district (RSID) for the maintenance of said streets and,

WHEREAS, the boundaries of the expanded district will include Windstone Estate Subd Lots 1 and 2, Blk 1; S29, T01 N, R25 E, 1211, Parcel 001, TR1 COS1211; S29, T01 N, R25 E, 1211, Parcel 002, TR2 COS1211 in N2; S S29, T01 N, R25 E, 1211, Parcel 000, TR3 COS1211 (less Indian Cliff Sub 2nd); S29, T01 N, R25 E, 1180, Parcel 001, TR1 COS 1180 AMND IN NW4; and S29, T01 N, R25 E, 1180, Parcel 000, TR2B-2B COS 1180 AMND, as well as the parcels already located in the district, Indian Cliffs 1st Filing and Indian Cliffs 2nd filing, Yellowstone County, Montana, described in Exhibit B and more particularly shown in Exhibit A (map) and

WHEREAS, pursuant to §7-12-2161(4), MCA, the Commissioners have the power of changing, by resolution, the boundaries of any maintenance district not more than once a year; and

WHEREAS, the boundaries of RSID 650M have not been changed within the last year; and

WHEREAS, the maintenance of road improvements as shown in Exhibit C is only an estimate of annual costs and is subject to cost fluctuations due to maintenance utilization levels and changes in material and labor costs of performing necessary maintenance; and

WHEREAS, the property assessment amount is subject to adjustment and will be established annually by the Board of County Commissioners; and

WHEREAS, the district shall be considered to exist perpetually unless included within another district providing the same services or assumed by a municipality.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Yellowstone County, Montana, deeming the public interest or convenience require, expands the following described Rural Special Improvement Maintenance District:

1. **DESCRIPTION OF DISTRICT.** The District is described by the exterior boundaries in Exhibits A & B.

2. **DESCRIPTION OF IMPROVEMENTS, DESCRIPTION OF MAINTENANCE, METHOD OF ASSESSMENT AND ESTIMATED COSTS.** Assessments collected on behalf of this district shall be used for the maintenance, preservation, and repair of the streets located within the boundaries of this district. All of the costs of the district shall be assessed equally for each lot within the district with an additional equal assessment for each lot which has a residence or has been issued a residence building permit by June 1 of each year (Exhibit D). Estimated costs are shown in Exhibit C, but costs shown are not exclusive of other eligible street expenditures.
3. **DURATION.** The district shall be deemed to be perpetual in nature unless absorbed and replaced by another district or municipality.


